#### #3387 - New Business

- Mr. Christians asked who is handling the Bailiff duties; the Chair stated the Trustees and Chad Wetter share the duties
- Mr. Christians asked about the location of the curb stops and the mapping system; the
  Chair stated that approximately 95% of the curb stops have been located. Some curb
  stops unable to locate due to landscaping. Mr. Christians stated for those unable to locate a letter should be written to the property owner, the Chair agreed with this.
- Mrs. Robinson asked if SEID is eligible for any grants, Mr. Forst stated that improvement districts are not eligible for Federal/Provincial grants.
- Mrs. Robinson asked if SEID has an Emergency Response Plan, Mr. Forst stated the District does, it is updated annually.
- Mr. Prystry asked if there is any benefit to having a water meter; Mr. Forst stated until all properties have a water meter installed SEID cannot charge for water by this method
- Mr. Christians asked about the cleaning of the reservoirs, Mr. Forst stated the reservoirs were professionally cleaned and inspected and results forwarded to Interior Health.
- Mr. Christians asked about the use of liquid chlorine, Mr. Forst stated this is more labour intensive and more expensive
- Residents using the park for private events must have liability insurance coverage
